## Rec Plex/City of WDM Updates - Kevin

- Will be delaying their season to avoid overlap with our season
- Plan is non-league and purely introductory to the sport. Same thing that they are implementing football basketball.
- Comments from City were that they have heard perception is that WDM Soccer *Club* insinuates competitive play rather than pure introductory program. Requests from community for parks 'n rec style introductory through the city itself.
  - We commented on our introductory phase being very similar and purely introductory. There is discussion of marketing updates and potential partnerships, e.g., linking their next phase to WDMSC.
  - o Billboards inside are annual purchase of \$5000
  - o Sideboards in ice rinks are \$600 annually
  - o TV ads inside building are \$100 per ad, 20 sec ad repeated, for the year

    - Requested volunteers to work at events; will donate money to WDMSC in response
